## CONTRACT AGREEMENT

This Agreement made this 16<sup>th</sup> day of March 2006 between the Road Development Authority (RDA) duly established in terms of the Road Development Authority Act No.73 of 1981 as amended and having its Head Office at "Sethsiripaya", Battaramulla, Sri Lanka (hereinafter called "the Employer") of the one part and Taisei Corporation of Japan, and having its Sri Lanka Representative Office at 0605, Hilton Colombo Residence, 200, Union Place, Colombo 02, Sri Lanka (hereinafter called "the Contractor") of the other part.

Whereas the Employer is desirous that certain Works should be executed by the Contractor, viz. Contract No. RDA/STDP/JBIC/D-K.3, JBIC Funded Section of the Southern Transport Development Project, from Kottawa to Kurundugahahetekma, Package 2 - Dodangoda to Kurundugahahetekma and has accepted a Alternative Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

The amount in the Form of Bid (Alternative Bid) is Sri Lanka Rupees Eight Billion, Two Hundred and Ninety Six Million, Eight Hundred and Forty Seven Thousand and Eight Hundred and Sixty Four only (SLR 8,296,847,864.00). It is the Contract Price given in the Letter of Acceptance which has been acknowledged by the Contractor. The summary sheet of the bid is given as Annex 1 to this Contract Agreement.

Now this Agreement witnesseth as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) The Letter of Acceptance;
  - (b) Memorandum of Understanding;
  - (c) The Form of Bid ;
  - (d) The Addenda to Bid;
  - (e) The Conditions of Particular Application (Part II);
  - (f) The General Conditions (Part I);
  - (g) The Appendix to Bid;
  - (h) The Specifications;
  - (i) The Drawings;
  - (j) The Bill of Quantities (Priced);
  - (k) The Data provided by the Employer;  
(Parts III, IV and V only)
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.






